All Workplace Representatives are to meet with their principals to ensure class sizes are within the maxima according to Article 20.2.1. Please send a MASTER SCHEDULE BY BLOCK on March 1st showing that class sizes are within maxima and flex and that there are no more than 20% of class using flex. If changes have been made to staff timetables, the in-school staffing committee should have been consulted.

As the staffing process is about to begin for 2020-21, we will be asking you to follow guidelines that will be sent out in the near future. We still have an outstanding grievance on in-school staffing committees, so will be closely monitoring staffing this year.

MAC 203-17 (AMPA 2020)

The Governance Review Committee proposed in December to force the merger of small bargaining units (<100 FTE) with larger units to make fewer bargaining units within Districts. This would have affected both our teacher and support staff units locally. This proposal met a lot of resistance.

In February, the Committee revised its position to propose voluntary mergers with a one-time financial incentive.

Media Campaigns

OSSTF continues its strong social media presence and the use of websites such as HereForStudent.ca and BargaingForEducation.ca. Please follow OSSTF, other unions, PE members, and local leaders and help spread our message to your own friends and followers with Twitter or Facebook.

OSSTF has begun a Trustee Lobbying Campaign that we are discussing and planning locally, as we are one of the few Boards who aren't being openly supported by their administrations and trustees.

Also, newsletters to School Parents' Councils have been sent out. Please make contact with your local school council staff liaison to make sure Parents' Councils are receiving newsletters from OSSTF.

Woman's Advocate Program, April 24-25, 2020

The creation of a Women's Advocate Program was approved at AMPA 2018 as part of the Annual Action Plan. The goal of the program is to provide support to members experiencing or impacted by domestic violence. OSSTF/FEESO knows, in addition to employers, unions have a role to play in protecting and supporting women in need.

Training of Women's Advocates will take place April 24-25, 2020, in Toronto. Provincial Office will cover the costs of delegates attending the training session.

Each District has been allocated 2-5 (3 for Algoma District – all BUs) delegates based on current FTE membership (see Appendix 1). Districts are responsible for determining the process for selecting its delegates. Geography and number of Bargaining Units should be considered. Districts are strongly encouraged to identify, wherever possible, at least one delegate from each employer group. An application template has been attached that can be used or adapted as needed. OSSTF/FEESO asks advocates to commit to participating for at least two years in the program.

Provincial Office will put out a call through social media encouraging interested members to contact their districts requesting an application that they would then submit to their District. Districts should also find opportunities to advertise this opportunity to their members.

Districts will review the applications, select their delegates, and register them with Provincial Office. A link to the registration site will be sent to local leaders in a follow-up email.

All delegates must be registered with Provincial Office by April 3, 2020.
