First of all, a big welcome to the Members of the Secondary School Occasional Bargaining Unit. I must apologize for not communicating with you sooner. Our original Roster was wiped out in June as we lost over 32 OTS to contract positions. What a win-fall for those members! There were also numerous resignations and new hires. The Board continues to post for OTs and recently had another round of interviews so they can increase the number of people on the Roster. So my

To give you some perspective, these are the following stats I have to the end of September:

original list was outdated and really has just been updated and completed! In the meantime....

- 82 people on the Roster (that covers the 6 areas and schools)
- 22/82 are retired teachers who will be limited to 50 days of work for the year due to the changes to the Ontario Teachers' Pension Plan rules (*had been increased from 50 to 95 days during the height of the pandemic)
- 12/82 LTO positions filled* several long-terms have been posted several times with no applicants
- At least 5 positions still vacant posted but not filled
- 27 unqualified teachers on the List
- 5 "unqualified" have secured long-term positions* Letter of permission

The Occasional Teachers' Bargaining Unit <u>NEEDS</u> some volunteers to serve on our Executive and a variety of Committees. None of these positions are overwhelming or require a lot of your personal time, but they need to be filled if we are to continue our work within the Occasional Teachers' Bargaining Unit.

- More importantly we need an operating **Executive** to carry out the business of the Occasional Teachers
- We need Members to serve on our Collective Bargaining Committee as we must prepare our next Collective Bargaining brief. (CA expired August 31, 2022)
- Training for any position can be provided variety of workshops also available
- These positions are valuable and are looked on favourably by the Board personal and professional growth

- NOTE: November 11 -12, 2022* Collective Bargaining Regional Meetings are scheduled in Sudbury OSSTF covers all the costs we need at least 3 people to participate (time release is also covered for travel, meals etc.)

COLLECTIVE BARGAINING SURVEY - IDENTIFYING AREAS OF NEED

- I will be sending out a very brief and condensed version of a survey that will help identify areas we will need to target in our next round of **LOCAL** bargaining under **Part 2** of our Collective Agreement. Please take the time to complete and return.
- NOTE: Part 1 CENTRAL TABLE BRIEF (PROVINCIAL) was prepared, endorsed and presented to the government prior to the commencement of negotiations. Provincial Updates on progress or lack of progress are distributed to you through email as they become available.

PAYROLL - PAY SHEETS - HEADS UP

A few things to keep in mind when submitting your time sheets in order to avoid issues with your pay and/or length of time between pays.

- Make sure you are using the proper **Pay Sheet** (was revised) and that there are **signatures on it** from the signing authority in each school AND your own signature
- Make sure the appropriate number of periods have been selected

 For example: 2/4 periods in morning or afternoon (in a block) = .5 of a day's pay

 3periods + on-call of up to 37.5 minutes=1 full day of pay
- Pay Sheets are **submitted on time** through the Pay Roll Department details for submission are found on the second page of Time Sheet
- Note: The schedule for pay periods can be found on your ADSB employee portal

LASTLY, "HEADS UP"...If you are asked (and you have the right to decline) and agree to cover an entire 4th period with no prep period, be sure that it is recorded as 4/4 and your pay for that day will be 1.33 of a day's pay...The Board and the Union established this process during the pandemic (waived the language in the current collective agreement) and should it be necessary to institute the practice this year, we have agreed to offer it to members when and if it is needed.
